- f) The Seller's catalogues, technical circulars, sales literature, price lists and other such documents are for the Buyer's general guidance only and the particulars contained in such documents shall not constitute representations by the Seller and the Seller shall not be bound thereby.

Orders and specifications 3. a)

- No order submitted by the Buyer shall be deemed to be accepted by the Seller unless and until confirmed in Writing by the Seller's authorised representative.
- The Buyer shall be responsible to the Seller for ensuring the accuracy of the terms of any order (including any applicable specification) submitted by the Buyer, and for giving the Seller any b)
- necessary information relating to the Goods within a sufficient time to enable the Seller to perform the Contract in accordance with its terms.

 The quantity, quality and description of and any specification for the Goods shall be those set out in the Seller's quotation (If accepted by the Buyer) or the Buyer's order (if accepted by the c) Seller). Unless confirmed in Writing by the Seller, all specifications, drawings and particulars of weights, dimensions and performance issued by the Seller are approximate only and the Seller d)
 - gives no warranty or representation that the Goods will conform with such specification.

 If the Goods are to be manufactured or any process is to be applied to the Goods by the Seller in accordance with a specification submitted by the Buyer, the Buyer shall indemnify the Seller against all loss, damages, costs and expenses awarded against or incurred by the Seller in connection with or paid or agreed to be paid by the Seller in settlement of any claim arising out of:-
 - infringement of any patent, copyright, design, trade mark or other industrial or intellectual property rights of any other person which results from the Seller's use of the Buyer's specification; or
 - (ii) Any impracticality, inefficiency or lack of safety or other defect in the Goods where such defect is due (whether in whole or in part) to faults or omissions in information, drawings, designs, instructions, or specification of the Buyer.
- The Seller reserves the right to make any changes in the specification of the Goods which are required to conform with any applicable statutory or EC requirements or, where the Goods are to e) be supplied to the Seller's specification, which do not materially affect their quality or performance. f)
- No order which has been accepted by the Seller may be cancelled by the Buyer except with the agreement in Writing of the Seller and on terms that the Buyer shall indemnify the Seller in full against all loss (including loss of profit), costs (including the cost of all labour and materials used), damages, charges and expenses incurred by the Seller as a result of cancellation.
